JOINT SEWAGE TREATMENT BOARD (Trustees Fuller & Meaney)

Resolution #2016 - 43

A resolution amending resolution #2016-16 in relation to modifying the 2015 Binghamton-Johnson City Joint Sewage Treatment Facilities Budget to account for recovery reimbursements received which are to be paid over to the JSTF's Owners.

WHEREAS, the Village of Johnson City (the "Village") is a joint owner of the Binghamton-Johnson City Joint Sewage Treatment Facilities (the "JSTF") with the City of Binghamton (the "City"); and

WHEREAS, the Board of Trustees of the Village and the Council of the City of Binghamton approve the annual budget of the Binghamton-Johnson City Joint Sewage Board ("JSB"); and

WHEREAS, Intermunicipal Agreement X sets forth the procedure for the JSB to request approval of budget transfers and modifications during the year or within 30 days thereafter so long as any transfers do not increase the JSTF's total budgeted expenses for the year; and

WHEREAS, the JSB has received litigation recoveries and reimbursements for flood recovery expenses incurred by the Village and the City which require corresponding reimbursement to the Village and the City; and

WHEREAS, the JSTF's operating budget does not have a dedicated budget line for revenue received in compensation for loss when such revenue is neither insurance proceeds nor flood damage reimbursements; and

WHEREAS, the JSTF's operating budget does not have a dedicated budget line from which to pay-out reimbursements of such revenues to the Village and the City; and

WHEREAS, resolution of four FEMA Project Worksheets compensating for June 2006 flood damage require that \$140,884.34 received by the JSB in a prior year be reimbursed to the Village and the City in their respective shares; and

WHEREAS, one of the litigation recoveries is subject to payment of a \$15,000.00 public adjuster's fee to the Sewage Board's public adjuster; and

WHEREAS, in consultation with the JSB's Fiscal Officer (City of Binghamton Comptroller), the JSB has proposed revenue neutral transfers and modifications to the JSTF's 2015 budgets to account for the receipt by the Sewage Board and reimbursement to the Village and the City of the litigation recoveries and flood recovery reimbursements received; and

WHEREAS, the Village wishes to amend Resolution #2016-16 duly adopted January 5, 2016 so as to conform to the provisions of City Permanent Ordinance No. 016-10, duly adopted by the City's Common Council ("Council") January 20, 2016,

NOW, THEREFORE, the Board of Trustees of the Village of Johnson City, duly convened in regular session, does hereby resolve to amend Resolution #2016-16 to provide as follows:

<u>Section 1</u>. That upon approval of a majority of the combined voting strength of the Board of Trustees of the Village and the Council of the City of Binghamton, the Joint Sewage Board Fiscal Officer is authorized and directed to create in the 2015 JSTF Revenue budget a new budget line:

J.42690 OTHER COMPENSATION FOR LOSS

<u>Section 2</u>. That upon approval of a majority of the combined voting strength of the Board of Trustees of the Village and the Council of the City of Binghamton, the JSB Fiscal Officer is authorized and directed to create in the 2015 JSTF Appropriations budget a new budget line:

J8130.54899 REIMBURSE OWNER RECOVERY EXPENSES

<u>Section 3</u>. That the Board of Trustees of the Village approves the following modifications to the 2015 JSTF budget:

- a. that Estimated Revenue budget line J.42680 (Insurance Recovery BAF) be increased by \$500,000.00;
- b. that Estimated Revenue budget line J.43960 (State Aid, Emergency Disaster Assistance) be increased by \$351,612.82;
- c. that Estimated Revenue budget line J.44960 (Federal Aid, Emergency Disaster Assistance) be increased by \$1,054,838.47;
- d. that appropriations be increased in the amount of \$15,000.00 on budget line J8130.54410.J0BAF (Professional Services BAF Remediation); and
- e. that appropriations be increased in the aggregate amount of \$1,891,451.29, to be added to the newly created appropriations line J8130.54899 (Reimburse Owner Recovery Expenses), and that upon approval of these budget modifications by a majority of the Board of Trustees of the Village and a majority of the Council of the City of Binghamton, the JSB Fiscal Officer is authorized and directed to make and journal such budget modifications.

<u>Section 4</u>. That the Board of Trustees of the Village approves the following modifications to the 2015 JSTF budget:

- a. that \$140,884.34 be transferred from Flood Capital Fund budget line JF8130.559001 (Flood Capital Fund Recovery Projects) to the general fund through budget line JF9901.59000 (Interfund Transfers); and
- b. that both Estimated Revenue budget line J45031 (Interfund Transfer) and the newly-created Appropriations budget line J8130.54899 (Reimburse Owner Recovery Expenses) be increased by \$140,884.34, and that upon approval of these budget modifications by a majority of the Board of Trustees of the Village and a majority of the Council of the City, the JSB Fiscal Officer is authorized and directed to make and journal such budget modifications.

<u>Section 5</u>. That this resolution shall take effect immediately, except as otherwise provided above.
